### **REPORT**

There are provisions in the IPC, which can be used by a student to register

very relevant and meaningful. Participants would benefit from this event. The program ended with a vote of thanks by Mr. SurendraChoudhary sir.

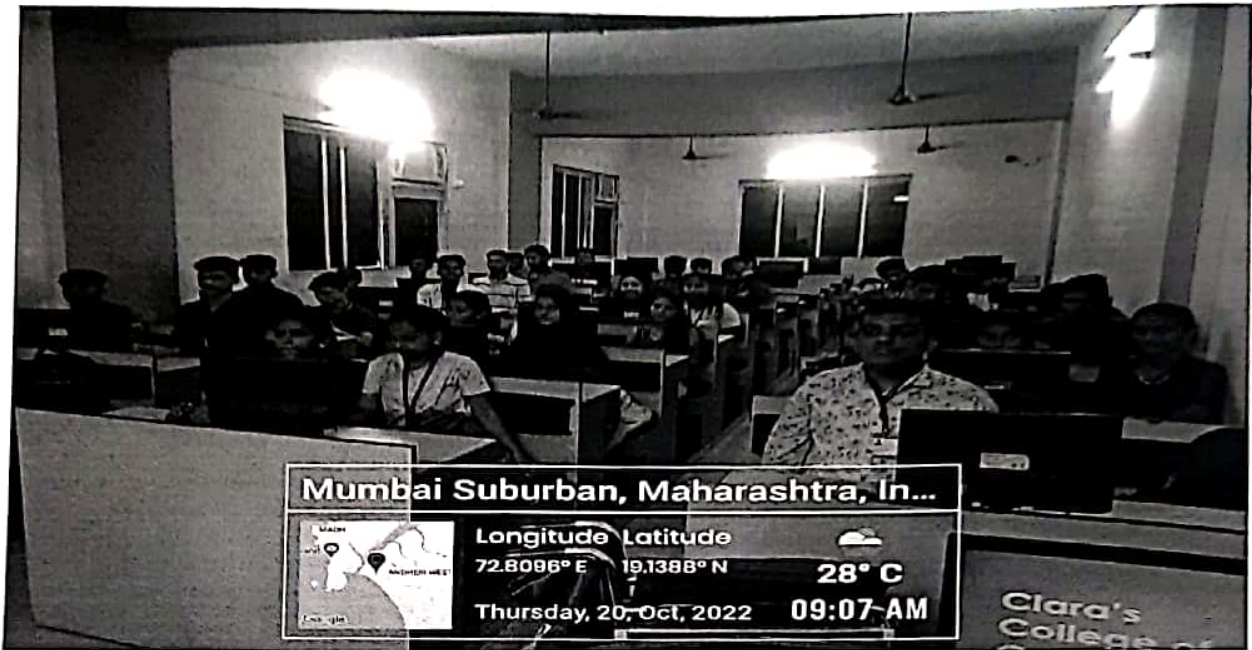
**Report**


1. The minutes of the previous meeting held on 18.06.2022 were read and confirmed.




